STIPULATED JUDGMENT AS TO DEFENDANT BERDINA WRIGHT

Pursuant to Rule 7054 of the Federal Rules of Bankruptcy Procedure, Plaintiff Nancy J. Gargula, United States Trustee for Region 21, and Defendant Berdina Wright stipulate and agree to the entry of this judgment based upon the facts alleged in the complaint, as amended, that initiated this adversary proceeding.

IT IS THEREFORE ORDERED that judgment is hereby entered against Defendant Berdina Wright pursuant to 11 U.S.C. §§ 105 and 110.


IT IS FURTHER ORDERED that Defendant Berdina Wright and any persons acting at her direction or in concert and participation with her that are not licensed attorneys admitted to practice before this Court are hereby enjoined from preparing, assisting with the preparation of, or filing, any documents in connection with any bankruptcy case or related proceeding in the Southern District of Georgia until further order of this Court.¹

IT IS FURTHER ORDERED that Defendant Berdina Wright shall refund \$4,975.00 to Debtor Charles Mills within ninety (90) days from the entry of this stipulated judgment. The refund shall be made by certified check, cashier's check, or money order payable to "Charles Mills" and delivered to the following address: Office of the United States Trustee, 2 East Bryan Street, Suite 725, Savannah, GA 31401.

IT IS FURTHER ORDERED that Defendant Berdina Wright shall pay a \$5,000.00 fine to the United States Trustee within one-hundred eighty (180) days from the entry of this stipulated judgment. The fine shall be paid by certified check, cashier's check, or money order payable to "United States Trustee Program" and delivered to the following address: Office of the United States Trustee, 2 East Bryan Street, Suite 725, Savannah, GA 31401.
