

**ORDERED**, that from this day on, the Defendants shall comply with Bankruptcy Code sections 526, 527, and 528. Further, it is

**ORDERED**, that this injunction is a continuing, permanent injunction and that it may be terminated only by the Order of a United States District Court or the Bankruptcy Court for the Middle District of Georgia upon motion therefor. Further, it is

**ORDERED**, that the Court shall retain jurisdiction over this matter for all purposes, including to enable any party to the Injunction to apply to the Court at any time for such further orders and directions as may be necessary or appropriate for the construction or implementation of this Injunction; to enable the Court on its own motion or upon appropriate motion by either party, with service on the other, to modify the provisions of the Injunction or to enforce compliance with any of the provisions of the Injunction or to punish violations of any of the provisions of the Injunction. Further, it is

**ORDERED**, that copies of this Permanent Injunction shall be served on the parties on the attached distribution list.



**CONSENT ORDER RESOLVING COMPLAINT**

A Complaint to Impose Fine and Enjoin Bankruptcy Petition Preparer and For Imposition

of Sanctions, and Review of Fees and Conduct of Debt Relief Agency was filed by the United States Trustee against the Defendants. The Defendants filed an answer to the complaint. The parties having agreed that the matter should be resolved as follows, it is, hereby

**ORDERED AND ADJUDGED** that in relation to this case, BERDINA R. WRIGHT and INFORMATIONAL SERVICES GROUP, INC., are debt relief agencies as defined in 11 U.S.C. § 101(12A) and bankruptcy petition preparers as defined in 11 U.S.C. § 110(a)(1) and acting as such, have violated provisions of the Bankruptcy Code, namely 11 U.S.C. §§ 526, 527, 528, and 110 (including section 110(e)(2) – providing legal advice to the Debtors). Further, it is

**ORDERED AND ADJUDGED** that pursuant to 11 U.S.C. § 110(i)(1), the Defendants, jointly and severally, shall pay \$2,000 to the Debtors, Linda Faye Mahone and Denson Mahone on or before December 1, 2018, and shall provide proof of payment to the United States Trustee contemporaneously. Further, it is

**ORDERED AND ADJUDGED** that the Defendants are enjoined from engaging in any conduct in violation of 11 U.S.C. § 110 in the future. Further, it is

**ORDERED AND ADJUDGED** that the Defendants shall comply with Bankruptcy Code sections 526, 527, and 528 from this day forward. Further, it is

**ORDERED AND ADJUDGED** that copies of this Order shall be served on the Defendants and the Debtors.
